Chair's Message

It is my hope that this will be the most unusual Chair's Message that I have to write. For that reason, it is focused on a few critical NCUTCD issues.

June 2020 NCUTCD Meeting Cancelation

The Executive Board has decided to cancel the June 2020 NCUTCD meeting in Virginia Beach, VA. The meeting is canceled, not postponed. Full refunds will be issued to those that have registered for the meeting. The Board considered many different factors in making the decision, the most important of which is the health and wellbeing of our members. Some of the most important factors considered (but not the only ones) include:

- The Virginia Governor has issued a shelter-in-place executive order through June 10 (one week prior to the start of our meeting).
- AASHTO has decided to cancel their Committee on Traffic Engineering meeting scheduled to take place the same week as our meeting.
- An expectation of greatly reduced attendance at the meeting due to travel restrictions if we were to hold the meeting as planned.
- Canceling the meeting comes with potential financial penalties. Fortunately, the Board and our prior Executive Secretary Bob Garrett, have done a good job of developing resources that provide us with the ability to address those penalties.
- I am asking the technical committee chairs to schedule virtual technical committee meetings for at least some portion of the time that we would normally be meeting in June. Although the meeting has been canceled, please keep your calendar open for June 17-19 so that you can participate in the online TC meetings.
- There will not be a virtual General Session on Thursday or Friday. The Council will not be meeting in a virtual environment unless needed to approve recommended docket comments for the MUTCD NPA.
- It is up to task force chairs to decide if they want to conduct virtual meetings. Work with Executive Secretary Richard Moeur if you are a TF chair and want to set up a virtual meeting.

MUTCD NPA

There is no official word on when the NPA for a new MUTCD will be published. I had hoped to have a sense of the status of the NPA before the Board made a decision about the June meeting. However, the regulations regarding the rulemaking process prohibit FHWA from indicating when we can expect the NPA to be published. It is possible that it could be published before June, in which case you can expect one or more special messages from me regarding how we will respond to the NPA.

Future NCUTCD Meeting Information

- January 2021: The January 2021 NCUTCD meeting is still planned to take place on January 27-29, 2021 (Wednesday-Friday). Our meeting will conflict with the annual meetings of TRB and ATSSA (see my prior Chair's Message). The extent of the conflict is unknown at this time and will depend partly on the date that the NPA is published and whether we will need to extend the NCUTCD meeting through Saturday. If the current health crisis extends into fall/winter, it could impact the January meeting.
- June 2021: Given the cancelation of the June 2020 meeting, we may hold the June 2021 meeting in Virginia Beach, VA instead of Seattle, WA. This is an AASHTO decision and we will coordinate with them as we always do. It may be some time before that decision is made.

NCUTCD Announcements

- Member Passing John LaPlante: On Saturday, March 21, John LaPlante passed away at age 80 after testing positive for the novel coronavirus less than two weeks earlier. John served as vice-chair of the Bicycle Technical Committee for many years and was a national champion for bicycle and pedestrian issues. He is survived by his wife Linda and daughter Leslie.
- Rules of the Road Committee: At the urging of Jim Pline, I am rebooting the Rules of the Road Committee. Ronnie Bell has agreed to chair this committee. The goal of the committee is to develop recommendations for the legal "rules of the road" that we can put on our website for use by state and local agencies. The focus is on the rules of the road that relate to traffic control devices. This is not an effort to update the entire Uniform Vehicle Code.
- New Feature Agency Practice: In my previous Chair's Message, I asked for a 1-pager on agency practices that have evolved from NCUTCD participation or recommendations. I did not receive any contributions. I hope you will consider developing one.

- NCUTCD Positions: Chair of the Signals Technical Committee since January 2016 and Chair of the ITE Delegation from 2012 to 2016. I attended my first NCUTCD meeting in June 1993 in Lake Tahoe, Nevada, when I joined the Signals Technical Committee and haven't missed one yet.
- Where you live: I have lived in Los Angeles County all of my life and reside in South Pasadena, California.

- **Professional Affiliations:** ITE Fellow and ASCE Member; registered Civil Engineer and Traffic Engineer in California; PTOE.
- **Involvement with Traffic Control Devices:** I started to become interested in traffic control devices as I approached driving age and when the construction of the extensive Southern California freeway system was in full-swing. I curiously noted the evolutionary changes such as glass button-letters to retroreflective sheeting, word message to symbol signs and signal mast arms.
