The New MUTCD is Here!

As I am sure you all know, the new MUTCD was published on Tuesday this week. I have already seen evidence of our members combing through the details to evaluate its content. Having had a couple of days to absorb it and hear thoughts from our members, I wanted to offer my thoughts and perspectives on the Manual and provide some direction for our future efforts.

Initial Response

Since Tuesday morning, I have been spending more time on email and meetings related to the MUTCD than I have been reviewing the new content. I am happy with the content I have been able to review and am particularly happy to see the language near the beginning of the Federal Register notice regarding the intended use of the MUTCD. This language addresses many of the misconceptions about the MUTCD that were expressed in some of the docket comments.

By and large, my review and the input I have received suggest that the FHWA has adopted most of the NCUTCD recommendations for the MUTCD provided before the NPA and in our docket comments. As I write this message today, I believe that the 2023 MUTCD is an improvement over the 2009 MUTCD. There are further improvements that can be made and I am grateful that the NCUTCD will finally be able to start doing what we do best – developing proposed changes for the current MUTCD that will become recommended changes upon Council approval.

NCUTCD Review Actions

Your review of the new MUTCD should focus on two aspects: short-term issues and long-term changes. The short-term issues review should identify any content of the new MUTCD that was added without following federal rules for rulemaking. My <u>previous Chair's Message</u> had detailed instructions on conducting this review. It is too early to have a good handle on this aspect of the review but so far, I think we are looking at few, if any, issues for Council to address at our Annual Meeting next month. If you find something you think falls into the category of "objectionable content," share that information with your technical committee chair as early as you can.

The review for long-term changes should focus on aspects of the new MUTCD that could be improved in a future revision/edition or new content that could be added. I believe that future initial revisions to the 2023 MUTCD will be targeted on specific issues and will be limited in scope. Accordingly, I have instructed the technical committee and joint task force chairs to prioritize any proposed changes to the 2023 MUTCD. As we become more familiar with the new Manual, the NCUTCD leadership will work on identifying priorities to recommend for future rulemaking efforts.

Anytime a document the size of the new MUTCD is published, there are bound to be errors in the document. If you see something that appears to be an obvious error, share that with your TC/JTF chair.
