The language proposed by FHWA for the future manual removes the options to placed pictographs on guide signs for colleges and universities as well as governmental jurisdictions. The use of pictographs on guide signs has been a practice used by states for decades and the removal of this option in the future is highly likely to place states in non-conformance with the next MUTCD as the removal of pictograph usage by states who have been using them will not likely occur.

30 DISCUSSION

GMI discussed the removal of the provision of the use of pictographs on guide signs. To 31 remove this option completely would place states in a situation where they would likely 32 violate the new MUTCD. The direction was to retain many of the change FHWA made 33 to this section, but to reinstate the current pictograph usage options. However, after 34 hearing details on the research conducted in relation to pictographs it was discovered 35 the research showed very little negative impact when one pictograph was added to a 36 guide sign, but distraction increased significantly when three pictographs were 37 The pictograph options were reinstated, but a guidance statement displayed. 38

47 Section 2E.35Section 2AK.04 OtherSupplemental Guide Signs

- 48 Support:
- 49 (01)Supplemental Guide signs can be used to provide information regarding destinations accessible from an
- 50 interchange, other than places displayed on the standard interchange signing. However, such Supplemental
- 51 Guide signing can reduce the effectiveness of other more important guide signing because of the possibility of
- 52 overloading the road user's capacity to receive visual messages and make appropriate decisions. "The
- 53 AASHTO Guidelines for the Selection of Supplemental Guide Signs for Traffic Generators Adjacent to
- 54 Freeways" is incorporated by reference in this section (see Page i for AASHTO's address).
- 55 Guidance:
- 56 (02)<u>A Supplemental Guide sign should not be installed unless a destination meets the criteria established by</u>
- 57 the State or agency policy (see Paragraph 5 of this Section). Statesand other agencies should adopt
- 58 anappropriate policy for installing supplemental signs using "The AASHTO Guidelines for the Selection of
- 59 Supplemental Guide Signs for Traffic Generators Adjacent to Freeways." In developing policies for such
- 60 signing, such items as population, amount of traffic generated, distance from the route and the significance of the
- 61 *destination, should be taken into account.*

- 63 (03)No more than one Supplemental Guide signshould be used on each interchange approach.
- 64 (04)A Supplemental Guide sign (see Figure 2E-24) should not *list display* more than two destinations <u>and</u>
- 65 <u>nomore than three lines of destination information</u>. Destination names should be followed by the interchange
- 66 *number (and suffix), or if interchanges are not numbered, by the legend NEXT RIGHT or SECOND RIGHT or*
- both, as appropriate. The Supplemental Guide sign should be installed as an independent guide sign assembly.
- 69 (05)Where two or more Advance Guide signs are used, the Supplemental Guide sign should be installed

- 83 (08)Guide signs for recreational or cultural interest destinations (see Chapter 2K) shall be

- 86 (09) A pictograph (see definition in Section 1A.13) may be used on a Supplemental Guide sign in
- 87 conjunction with a destination that is associated with governmental agencies, military bases, universities,

- 99 (13) The maximum dimension (height or width) of a pictograph shall not exceed two times the
- 100 upper-caseletter height of the destination legend and shall not exceed the size of a route shield on
- 101 the guide sign. If used, the pictograph shall be located to the left of thedestination legend it
- 102 represents, except as provided in Paragraph 9 for the park-ride SupplementalGuide sign.
- 103 (14) The maximum dimension (height or width) of a pictograph shall not exceed two times the
- 104 upper-case letter height of the destination legend and shall not exceed the size of a route shield on
- 105 the guide sign. If used, the pictograph shall be located to the left of the destination legend it
