22 This proposal would expand the use of general service signs to bikeways.

DISCUSSION

25 Chapter 2I of the Manual on Uniform Traffic Control Devices provides for a category of guide
26 signs known as General Service signs that are intended to provide road users with information
27 signing for traveler services. It also states that general service signs may be used on any class of
28 highway where an engineering study determines a need. This proposal adds D9 services signs to
29 Chapter 9B of the MUTCD.

Section 9B.20a General Service Signing for Bikeways

[Note: this section may be inserted anywhere between sections 9B.20 and 9B.25]

Option:

01 General Service signs (see Chapter 2I) may be used on bikeways.

Standard:

02 General Service signs intended for viewing by both bicyclists and other road users shall conform to the sizes in Table 2I-1.

Option:

03 General Service signs intended for the exclusive use of bicyclists may be of reduced size.
