This is a recommended change to the MUTCD that has been approved by the NCUTCD Council. This proposal does not represent a revision of the MUTCD and does not constitute official MUTCD standards, guidance, or options. It will be submitted to FHWA for consideration for inclusion in a future MUTCD revision. The MUTCD can be revised only through the federal rulemaking process.

SUMMARY: Proposing technical correction to several figures in Part 8 to remove North Arrows. Covers

Figures 8C-1, 8C-3, and 8C-4 in Chapter 8C; Figure 8D-2 in Chapter 8D; and Figures 8E-1

through 8E-4, 8E-6, and 8E-9 in Chapter 8E. All noted Figures show North Arrows that were not part of the original NPA and appears to now be "new content".

DISCUSSION:

A North Arrow has been added to Figures 8C-1, 8C-3, and 8C-4 in Chapter 8C; Figure 8D-2 in Chapter 8D; and Figures 8E-1, 8E-2, 8E-3, 8E-4, 8E-6, and 8E-9 in Chapter 8E without public review. The affected figures apply to all roadways and not just roadways with a north-south configuration. The 11th Edition introduced North Arrows on these figures, however this was not included as part of the NPA and is new content.

MUTCD figures are meant to represent common scenarios that may be applied along any roadway regardless of traffic or cardinal direction (i.e. north, east, south, and west). North Arrows are typically placed along plan sets that have geographical references such as Latitude

and Longitude. North Arrows in a figure may confuse the end users in the field allowing them to

assume that they may only be able to reference any of the MUTCD figures for a north-south configured roadway and cannot for any other directional roadway.
